# TU Delft OPEN Publishing

### **AGREEMENT**

(Publishing agreement for Edited Books)

This is a publication agreement ("this agreement") regarding an Edited Book (Edited Volume) of digital scholarly or scientific chapters written by different authors entitled [XXX] ("the Edited Book") to be published in TU Delft OPEN Publishing ("the publisher").

The parties to this Agreement are:

**name of Editor(s) XXXX,** on behalf of any other editors of the Edited Book, and

TU Delft, participating in its capacity as open access publisher under the name TU Delft OPEN Publishing.

#### 1. The publisher will

- a. Publish all chapters of the Edited Book under an open CC-Licence (CC-BY or CC-BY-NC): free access to all content without login/paywall. Free reuse of the content where authors retain their copyright;
- b. Provide the editor(s) with advice and training on all technologies and systems;
- c. Apply for and assign International Book Serial Number (ISBN) and a Digital Object Identifier(DOI);
- d. Manage inclusion of the Edited Book in relevant third-party indexing platforms as Directory of
- e. Open Access Books (DOAB);
- f. Provide continuous electronic access to the Edited Book on TU Delft OPEN Publishing;
- g. Provide the editor(s) with timely notification of any technology or system changes that may impact the availability of the Edited Book;
- h. Provide a print on demand service for the Edited Book with an external party to be found on the platform of TU Delft OPEN Publishing.

#### 2. The editors will

- a. Grant to the publisher a non-exclusive, worldwide license for electronic hosting and dissemination as well as for providing printing on demand services and disseminating metadata;
- b. Take full responsibility for administration issues of the Edited Book, including determining the title, mission, scope, and accepted conference papers; developing policies governing the peer review process, authors rights and responsibilities manuscript submission requirements, and style guidelines; appointing editors, reviewers, and other staff; and all other matters pertaining to the administration of the Edited Book;
- c. inform the authors and conference organisers about the publishing conditions and license;
- d. provide the Publisher with timely and correct notification of any administrative changes relevant to hosting and distribution of the Edited Book under this Agreement;
- e. grant the Publisher authority to index the Journal to Directory of Open Books (DOAB);
- f. grant the Publisher authority to apply for inclusion of the Edited Book and all contents published under this Agreement in relevant third-party indexing and abstracting services;
- g. take full responsibility for obtaining content contributors' consent to include their material in the Edited Book under the conditions of this agreement, and obtain necessary permissions for re-use of any third parties or non, copyrighted materials.

#### 3. Attribution

the following citation to the original publication of the Edited Book is included in any attribution statement: "[year of first publication] [Title Edited Book] [Authors' name]", the attribution requirement of the Creative Commons license of paragraph is fulfilled.

#### 4. Effective date

The effective date of this Agreement is at the moment of the signature of the editor(s) as representatives of the Edited Book and the Publisher together, and continue indefinitely unless either party provides 3 months written notice of intent to terminate.

#### 5. Termination

In the event of termination of this Agreement and transfer of the Edited Book contents of the Agreement to a third party, the Publisher will cooperate fully and make all reasonable efforts to provide a smooth transition of all necessary content and metadata published or produced under this Agreement to whatever service provider the editor(s) designates.

#### 6. Royalties

TU Delft OPEN Publishing has a clear policy regarding the remuneration of its authors. As a non-for-profit publisher and service provider, we refrain from any form of royalties for authors. For that reason, there are no financial rewards for authors publishing via TU Delft OPEN Publishing.

#### 7. Processing charges

TU Delft OPEN Publishing has no processing charges and no publication charges for institutional author(s) and editors. Specific publishing requests as design may be done at a minimum cost. These additional costs will be recovered from the editors budget. This will be done with the approval of the author(s)

#### 8. Claims

The editor(s) agree to indemnify TU Delft OPEN Publishing against any claim or action alleging facts which, if true, constitute a breach of any of the foregoing warranties or other provisions of this agreement, as well as against any related damages, losses, liabilities, and expenses incurred by TU Delft OPEN Publishing. This indemnity also applies to any photographs, drawings or other illustrations supplied by you in the Edited Book

#### 9. Print on Demand

If you desire to publish the Edited Book in print, TU Delft OPEN Publishing will provide a third party on their platform. TU Delft OPEN will not act as a printing partner themselves.

#### 10. Dutch law

This is the entire agreement between editors of the Edited Book and TU Delft OPEN Publishing, and it may be modified only in writing. It will be governed by the laws of the Netherlands and any disputes about it will be settled by the Dutch courts. It will bind and benefit your respective assigns and successors in interest, including your heirs. It will terminate if TU Delft OPEN Publishing does not publish the Edited Book in any medium within one year of the date of your signature.
