SRM helps you in a structured way to identify your stakeholders with state of the art technology, to design a Stakeholder Engagement Plan according to the international Golden Standard IFC; to identify the appropriate impacts and accompanying mitigation measures, and to report back to authorities for permitting procedures. IFC SRM is considered as international best practice and globally the most widely used method by Financial Institutes and Multinational Companies to improve social performance.

The course also pays attention to the similarities and differences with the two most widely used methods in The Netherlands; SOM and process management.
